The Australia Award Standardisation and Product Compliance for Virgin Coconut Oil and Spices Short Course acknowledged the significance of Australia's relationship with Indonesia and the opportunities arising from IA-CEPA. In alignment with VISI Indonesia 2045, the course aimed to support the Government of Indonesia's development pillar of sustainable economic growth by focusing on key international trade priorities, including the acceleration of export growth through high value-added goods and services.

Led by Associate Professor Robin Roberts and Dr Ben Mullen, the course was attended by 20 industry professionals from Indonesia, strengthening the export competitiveness of the country's regulators and businesses in the virgin coconut oil and spices sectors.

Each participant leveraged their newfound insights to refine their products, assess potential improvements, and identify strategies for successfully entering the Australian market. The projects were then presented to course leaders and peers for constructive feedback and evaluation.

Pre-Course Workshops

The 3-day Pre-Course workshop took place in Jakarta Selatan, Indonesia between 21 – 23 May 2024. The pre-course was presented by the course leaders and was designed to introduce the program objectives and expectations to the participants as well as provide them with an overview of the main topics.

Post-Course Workshops

The 3-day Post Course workshop was held in Jakarta, Indonesia between 15 – 17 October 2024. During the Post Course participants completed workshops and activities, summarising their learning from the course. Participants also had the opportunity to present their Award Projects, providing an opportunity for peer feedback and potential collaboration.
